

## AMCOT COOLING TOWER ST & R-LC SERIES COOLING TOWER WARRANTY STATEMENT

## Ten Year FRP – Two Year Fill Media - One Year Total Product

AMCOT COOLING TOWER CORPORATION warrants the fiberglass components of their ST & R-LC series cooling towers for a period of ten (10) years from the date of shipment by AMCOT COOLING TOWER

CORPORATION. Warranty coverage ensures that the fiberglass components of the ST & R-LC series cooling tower will be free of defects in materials and workmanship. In addition, AMCOT COOLING TOWER CORPORATION warrants the fill media used in the ST & R-LC series cooling towers for a period of two (2) years from the date of shipment by AMCOT COOLING TOWER CORPORATION. Any component not mentioned previously will be guaranteed to be free of defects associated with materials or workmanship for a period of one (1) year from the date of installation or for a period of eighteen (18) months from the date of shipping, whichever time expires first, by AMCOT COOLING TOWER CORPORATION. The components that are included in the one (1) year or eighteen (18) month coverage period include; spray distribution components, mechanical components, fittings, fill support, mechanical supports, motor, fan assembly, inlet louvers and louver supports and any other component that makes up the entirety of the ST & R-LC series cooling tower as furnished by AMCOT COOLING TOWER CORPORATION.

No other warranties written or verbal will supersede the above warranty statement. The sole remedy for breach of the warranty as stated above will be the repair or replacement of the equipment by AMCOT COOLING TOWER CORPORATION at its option. Warranty coverage does not include freight charges or any labor associated with the warranted component. Freight and Labor will be the customer's responsibility. Any third party labor or components that are installed onto the unit not supplied by AMCOT COOLING TOWER CORPORATION after unit is shipped by AMCOT COOLING TOWER CORPORATION is not included or covered by this warranty. In addition, warranty coverage will be void if the owner does not perform preventative maintenance as recommended and operate the cooling tower in accordance to AMCOT COOLING TOWER CORPORATIONS' operation and maintenance manual for the ST or R-LC series cooling tower. AMCOT COOLING TOWER CORPORATIONS' standard warranty as stated above is void in the event of natural disasters, riots, wars, or acts of God which result in the loss of the cooling tower. Under no circumstances will AMCOT COOLING TOWER CORPORATION be liable for lost profits, lost savings, personal injuries, incidental damages, economic loss, property damage, or any other consequential, incidental, special or contingent damages. In addition, AMCOT COOLING TOWER CORPORATION shall not be responsible for any injuries or damages of any kind whatsoever under any theory of tort to the extent caused by misuse of the product by the buyer or any third party.

Owner agrees to all terms outlined above in the stated warranty and this agreement is acknowledged upon owner's issuance of a purchase order and AMCOT COOLING TOWER CORPORATION agrees to the above warranty at the time of purchase order acceptance.
